The contract Notice-To-Proceed was issued to Kiewit Infrastructure West Co. (KIWC) on June 7, 2018. Heavy construction is scheduled to continue through the summer of 2020. **UPDATES FOR ONGOING ACTIVITIES**

KIWC performed the following work in December:

***Nuuanu Ave. between School St. & Wyllie St.***

- Underground relocations of water lines at the intersections of Kuakini St. and Bates St.
- Surveying and potholing to confirm locations of existing underground utilities and geotechnical investigation at intersection of School St.

***Pali Hwy. between Wyllie St. & Coelho Way***

- Surveying and potholing to confirm locations of existing underground utilities at various locations.

***Pali Hwy. between Coelho Way & Ahi Pl.***

- Construction of guided bore pipe installation shafts at various locations in the town bound shoulder lane between Coelho Way and Ahi Place.

***Pali Hwy. between Ahi Pl. & Ahipuu St.***

- Convert a pocket of the Honolulu-bound shoulder of Pali Hwy into a project staging area.

**JANUARY / FEBRUARY FORECAST OF ACTIVITIES**

The activities listed below are scheduled to continue and/or begin in January and/or February. The approximate locations and work hours for these activities are shown on the attached maps.

***Nuuanu Ave. between School St. & Wyllie St.***

- Underground relocations of water and gas lines at the intersections of Kuakini St., Pauoa Rd., and Bates St.
- Installation of new sewer pipelines and manholes, including trench excavation and trench restoration, at various locations between School St. and Judd St.

***Pali Hwy. between Coelho Way and Ahi Place.***

- Construction of guided bore pipe installation shafts at various locations in the town bound shoulder lane between Coelho Way and Ahi Place.

**TRAFFIC UPDATES FOR JANUARY / FEBRUARY**

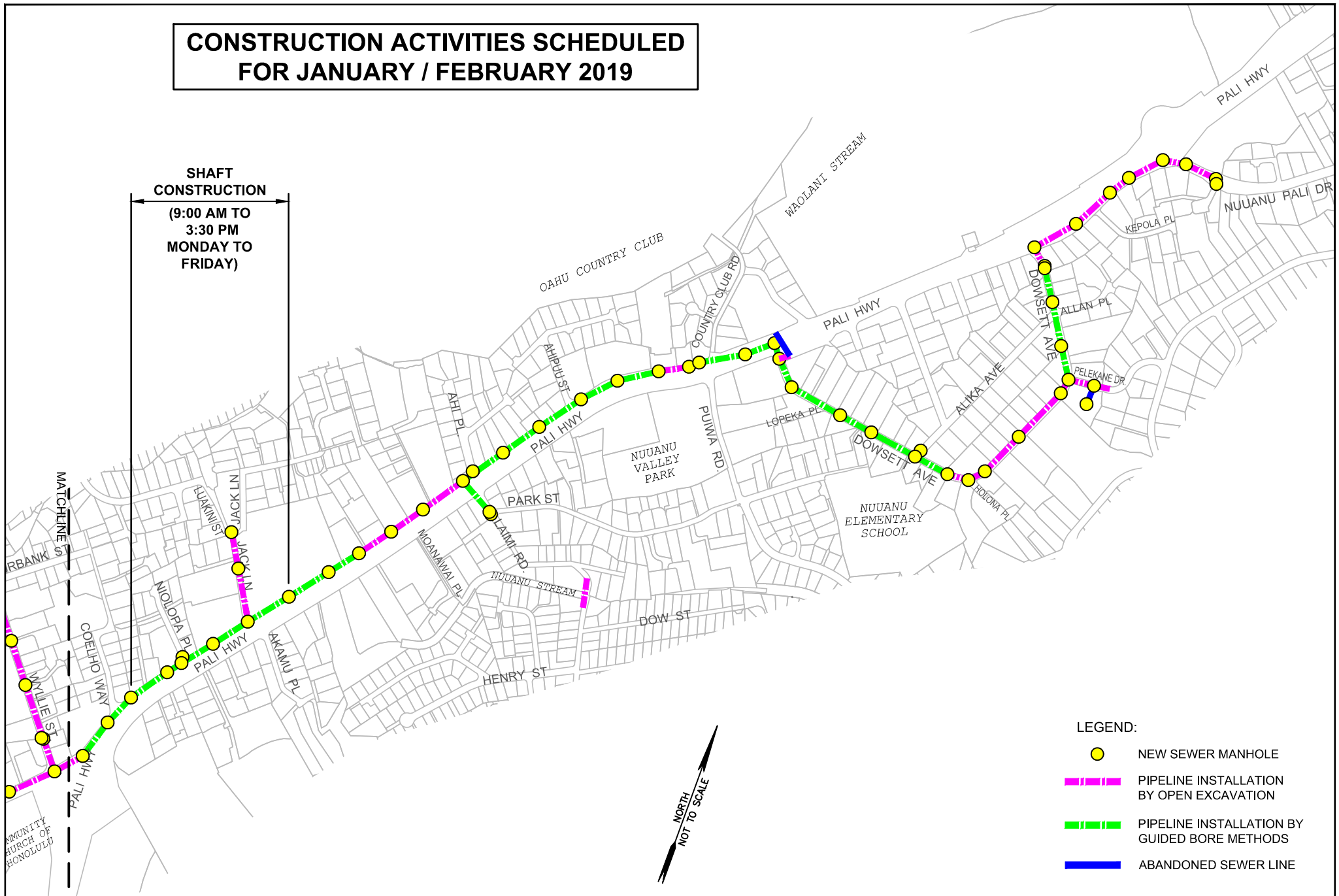
Daytime construction work will require relatively isolated lane closures at several locations on Nuuanu Ave., Kuakini St., and Pali Hwy. Work on Pali Hwy. will involve temporary closure of the right-most inbound travel lane during work hours. Access to driveways will be maintained via right turn motions from the open travel lanes fronting them; however, access to some driveways via left turn motions may not be available due to required traffic control configurations. Please observe the posted construction traffic signage. Thank you for your patience!

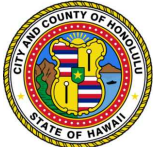

- ABANDONED SEWER LINE

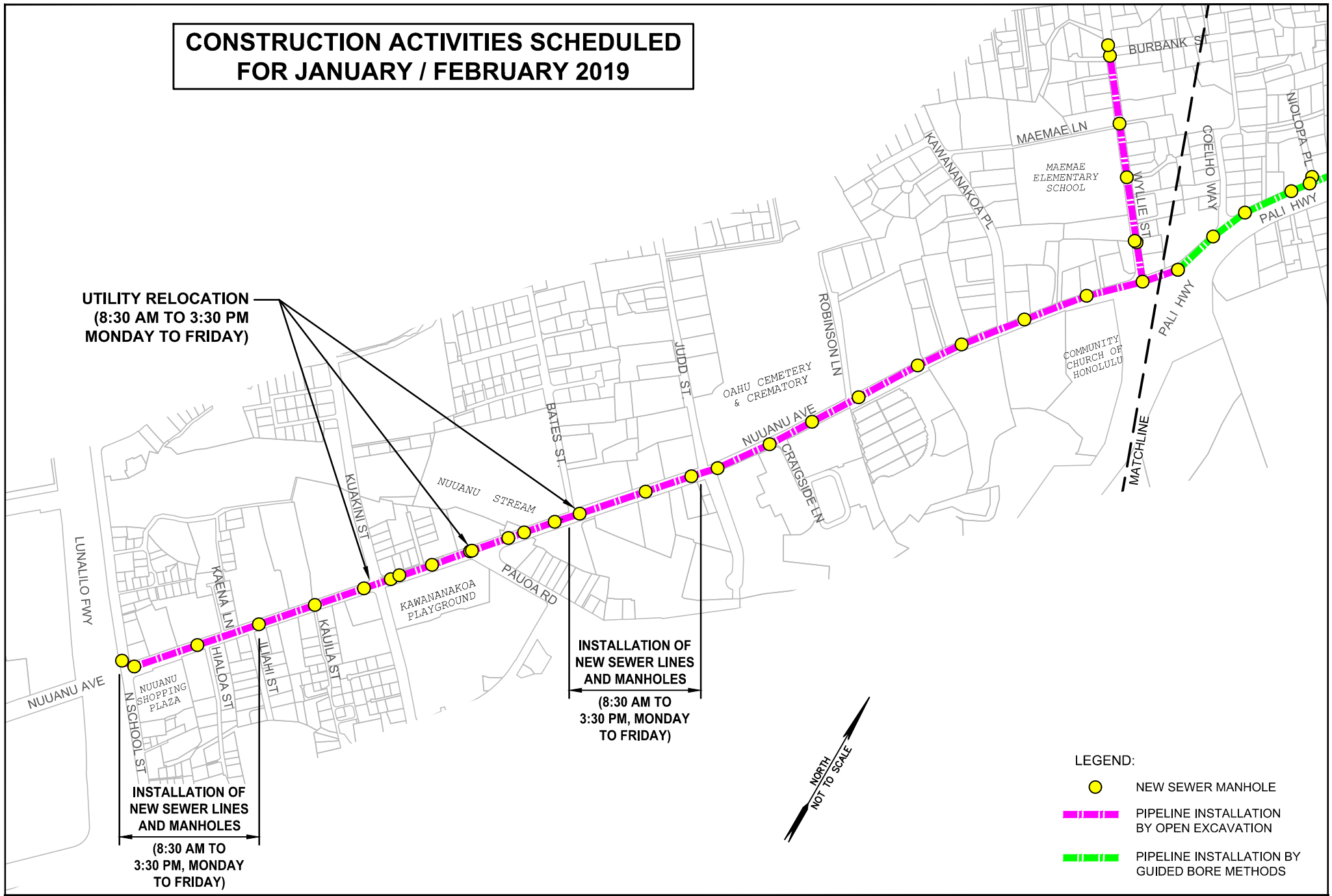
